### Plaintiff's Responses And Objections To Defendant's Second ...

In short, there are four basic code-compliant responses one must utilize, in whole or in part, for each particular RPD: (1) There will be no production of any documents whatsoever based solely upon a legal objection(s); (2) There will be a production of all documents without any objection; (3) There will be a production of documents, in part, in that some documents will not be produced based upon a legal objection(s) and/or an inability to comply; and (4) There will be no production of any ...

g., The term “\_\_\_\_\_” requires Plaintiff/Defendant to speculate as to what documents might be responsive. g., The phrase “\_\_\_\_\_” calls for documents proving a negative. It is unduly burdensome and oppressive. g., because it is calculated to annoy and harass the party. g., because numerous documents may tangentially refer to this request.

**Sample Language for Freedom of Information Act Responses**

Thus, a responding party can no longer provide vague responses as to what documents are actually being produced in response to a document request. Instead, a responding party is required to specifically state if documents will be withheld based on the specific objections raised. See Fed. R. Civ. P. 34, Advisory Committee Notes to 2015 ...

The California Code of Civil Procedure now requires “[a]ny documents or category of documents produced in response to a demand for inspection, copying, testing, or sampling shall be identified with the specific request number to which the documents respond.” Cal. Civ. Pro. § 2031.280(a). This is a major departure from the prior rule.
